SUPPLEMENTAL DEED

relating to land at Manor Farm, Seer Green, Buckinghamshire

THIS DEED is made the sixteenth day of July One thousand nine hundred and seventy-nine **BETWEEN GEOFFREY PERFECT HOLDINGS LIMITED** whose Registered Office is at Church Road, Penn in the County of Buckinghamshire (hereinafter called "the Company") of the one part and **CHILTERN DISTRICT COUNCIL** of Elmodesham House, 42 High Street, Amersham in the County aforesaid (hereinafter called "the Council") of the other part **IS SUPPLEMENTAL** to a Deed of Undertaking under Section 12 of the Buckinghamshire County Council Act 1957 dated twenty-first day of June One thousand nine hundred and seventy-three (hereinafter called "the Original Deed") made between the Company (by their then name of Frank Perfect & Sons Limited) of the one part and the Rural District Council of Amersham of the other part **AND IN VARIATION** to a Supplemental Deed of Undertaking under Section 12 of the Buckinghamshire County Council Act 1957 dated eleventh day of January One thousand nine hundred and seventy-seven (hereinafter called "the Supplemental Deed") made between the Company of the one part and the Chiltern District Council of the other part.

WHEREAS:

1. The Company has since the execution of the Supplemental Deed submitted a further planning application numbered CH/1318/78 which has amended and varied in part the Supplemental Deed in respect of Plots 56 to 61 inclusive of the Manor Farm Estate, Seer Green, Buckinghamshire which Plots are shown edged red on the 1/500" scale plan marked A attached hereto.
2. The Council as Local Planning Authority have granted permission to the Company in respect of the aforementioned planning application on sixteenth August One thousand nine hundred and seventy-eight.
3. The Company has submitted and have approved minor amendments to the approved planning permission CH/318/76 on sixteenth June One thousand nine hundred and seventy-seven and eighth March One thousand nine hundred and seventy-nine which have amended and varied in part the Supplemental Deed in respect of the Plots 38-41 inclusive of the Manor Farm Estate aforesaid which plots are shown edged red on the plan marked B attached hereto.
4. The Company has submitted and the Council has approved on thirty-first day of October One thousand nine hundred and seventy-eight a minor amendment to the approved planning permission number CH/318/76 which has amended and varied in part the Supplemental Deed in respect of plots 53-55 inclusive of the Manor Farm Estate aforesaid which plots are shown edged red on the plan marked C attached hereto.
5. The Council has agreed to vary the provisions of the Original Deed and the Supplemental Deed in manner following.
6. The Company have agreed to enter into this deed in accordance with Section 6 of the Buckinghamshire County Council Act 1971 and with Section 52 of the Town and Country Planning Act 1971 with a view to amending the Original Deed and the Supplemental Deed as hereinafter appearing so far as they relate to the land edged red on the plans attached hereto and to give the Council an undertaking in accordance with Section 12 of the Buckinghamshire County Council Act 1957.

NOW THIS DEED WITNESSETH:

1. The Original Deed and the Supplemental Deed shall henceforth have effect as if the plans attached thereto had shown the areas coloured blue yellow and green on the plans attached hereto in place of the areas coloured blue green and yellow on those parts of the plans attached to the Original Deed and the Supplemental Deed which correspond with the portions edged around with red on the plans attached hereto.
2. The Company hereby undertake and covenant with the Council in accordance with the provisions of Section 12 of the Buckinghamshire County Council Act 1957 and Section 6 of the Buckinghamshire County Council Act 1971 that the Company and their successors in title and assigns will abide by observe and perform each and every one of the agreements and conditions incorporated herein.
3. Save as varied by this Deed and the Supplemental Deed (and by two further Supplemental Deeds dated 6 April 1976 and 15 September 1977 which do not affect or relate to the areas edged red on plans A B and C attached hereto) the provisions of the Original Deed shall remain in full force and effect and the Company **HEREBY** renews the undertakings therein given.
